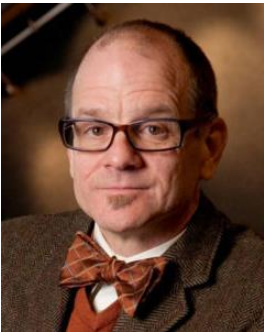

## BACKGROUND ON SNP ALLIANCE & QUALITY MEASUREMENT

SNP Alliance and its *Performance Evaluation/Quality Leadership Group* has, and will continue to, provide analysis, representation, advocacy, and education around Medicare Advantage quality measurement and performance evaluation (such as through MA Part C and D Stars measures and MMP quality measurement under the Financial Alignment Demonstration).

We have been working for several years to bring *more awareness to measurement and methodology issues in Stars when applied to SNP and MMP populations*. We comment on CMS proposed regulation, work with nonprofit and governmental agencies such as NQF, NCQA, respond to requests for information from many organizations, including ASPE, MedPAC, GAO, and participate in national Technical Expert Panels and Committees.

## SESSION FOCUS



We will take this hour to focus on how we can *provide thought leadership* to frame a *different approach around quality measurement for complex care* populations as are served by SNPs and MMPs.

Characteristics of the quality measurement system should reflect these populations—for example:

- Using *a core set of meaningful measures*,
- *Aligning* these identical measures *across key services and settings*,
- Defining or addressing *attribution and shared accountability*, and
- Ensuring *appropriate risk adjustment* and consideration of *social determinant of health risk factors* and care complexity
